All trophies have been paid for already. We will order patches and shirts for sale at states. Treasurer's report filed for audit.

Regional Reports

- Region 1& 6- Dale Moll- 603 students registered....100 more than last year report filed. They are using an online feedback system and the judges as well as students liked the system. It uses live scoring and if the judges score in error, it gives them a warning. There is a possibility of running this app at states for several events. Dan Warnaka is working on this app and is currently a sophomore at PSU. THANKS!!
 Region 1&6 work together but 6 is losing programs due to retirements. Big goal is recruitment.
- Region 2 Rich Nolt conference will be held on Feb 8th
- Region 3 Jana Bonds for Jason Jarrett –report on file
- Region 5&9 Chris Weaver 45 chapters last year, 59 this year. 32 events at the HS/MS level. New event is nano-tech through Lehigh (\$500 given) and software. Testing a beta version of iServices for Chris. Has the Calculater Robot form.
- Region 7 –Emil Stenger -Feb 15th and two other schools have been added. They were from region 8 originally but are closer to region 7.
- Region 8 Jeff Seamans Conf. is Feb 1st at Park Forest MS. Brandt has been out due to family concerns

Team Reports

State Officer Team – Each officer will present ind. Proposals

Max-Recycling Challenge – working on publicizing the challenge...working with the Green Comm. Victoria – Mindcraft event in place of Got Game. Mr. Ferry created the server for this event Lisa – "Business" Special interest sessions'. Working on Parliamentary procedure and submitted an event and rules to CRC (which were declined) on Business

Sam – Working on a 'Special interest session on running for state office'.

Ben – Relay for Life – NASCAR event

Mandy – Judges feedback form posted on website and getting the scans that the judges fill out (online –SciVis-HS and Med Tech Issues -MS). Dale said the kids have been working hard to get the conf. together. Chris Weaver asked that all advisors get the work out about the Green initiative and the recycling program (http://patsa.org/article/green-committee-hhw-recycling-challenge)

 State Conference Team- Lauren – the conference is on track and contacts have been made. Rates and dates are now posted. VEX and PA Robtics will run with Matt Cullen (Timberstone). CRAM CD will arrive in Feb. Participation forms are updated and on the web site due to liability and medical and photograph any child.

Check the rules, tests and problems on the CRAM disk prior to the event. Wayne has inventoried the supplies and will buy some items for the conference (computers, DVD readers). After talking, it was agreed that Ryan Ferry's company would supply computers to view events (four or five). He and Wayne will get together on software needs. Judges and coordinator emails will go out shortly. One event that is difficult is Junior Solar Sprint...looking for a coordinator and the sun. *No big schedule changes*. The program and special awards are coming together as well as Special Interest sessions (especially for MS kids). The program may include a feedback or validation form in the program so kids hold onto their programs and also write feedback for their instructors, etc.... Stamps may be used to validate attendance.

Mike and Bob are working together on vendors.

Hotel registration: please give all medical needs or extenuating circumstances please communicate to Lauren directly! Card keys with TSA logo will be distributed.

Occupancy: some kids were put in the condos versus a double or triple occupancy...this needs to be defined.

Dance and Relay for Life are on track.

Middle School Structural: question by Emil to the CRC (John McConnell-TSA Structure MS Coordinator) about wood size and adhesives. Emil did not receive a response back. Flight Challenge: Students must bring their own building materials. What about the quality of the balsa?

National TSA did not send banners or gold seals as promised to some chapters. Dennis will look into it. Laura will contact National on Monday, Jan. 21st and ask questions.

• Technology Team – Chris Miller – Working to make sure iServices is running effectively. Spending the last month getting familiar with FileMaker software and interface. The software update should be implemented by States. Chris showed the features of the new software as it pertains to iServices. Teams are now going to be assigned team '901 or 902' versus team 100, 200, etc... This number should be identified on their binders and any event submission.

- STEM Judy Hawthorn attended the PSTA conference and the STEMathon planning meetings and worked to integrate the value of TSA to both. STEMathon will be Aug. 5&6 at the Radisson. I will be working on trying to have influence on the new 'Race to the Top (52Mil) grant received by Early Childhood to use for STEM (http://www.politicspa.com/pa-wins-race-to-the-top-grant-for-early-learning/53818/).
- Scholarship –only one applicant now. John spoke about the Clark scholarship (5 all together) and said they have also hired 2 TSA kids.
- Bylaws John reported that the resolutions submitted by the officer team was reviewed and now needs rationale. The explanation (rationale) was worse than the resolution itself and they submitted a sub-standard written rationale.
- Finance inactive (look at the minutes from Bucknell 2010 to see what was the definition of Finance comm. It may have been replaced by the Foundation)
- Redistricting critical mass in 5&9 but they are at critical mass in region 5 and need to figure out to alleviate the numbers. Redistricting would solve the problem.
